On 15/06/2020 NRW received a report via our Incident Communication Centre of " waste odour, possibly burning waste, causing a yellow cloud coming from inside one of the buildings at J Morris and co scrap/skip company".

NRW contacted Morris&Co regarding this report on 25/06/2020. We received a reply on 30/06/2020 explaining that this yellow cloud may have resulted from a breakdown of the dust extraction system on site, but the issue was now resolved and remedial action had been taken.

NRW would like to thank Morris&Co for explaining the potential source of the incident. However, **section 4.3.1(a)** of your site permit explains that NRW should be informed of "any malfunction, breakdown or failure of equipment or techniques, accident, or emission of a substance not controlled by an emission limit which has caused, is causing or may cause significant pollution". As we must regulate all permitted sites consistently, we must produce this CAR form and apply a minor score (Cat 4) due to this incident not being reported to us following the breakdown.

Please ensure any breakdowns that may cause the release of uncontrolled emissions are reported to NRW as soon as is possible. This will allow us to respond to any incidents that may be reported to us as a result.

If you have any further questions please do not hesitate to contact us.

Any compliance criteria not highlighted in the above summary should be considered as not assessed.
