NRW is of the opinion that the operator has breached condition 2.1.2 of the permit in relation impermeable pavement/bunding and storage of drums and other mobile tanks (B4 Containment of stored materials CCS = 3).

The impermeable pavement is cracked in a number of places and requires replacing or repairing as per maintenance requirements of the working plan and permit.

Drums/mobile tanks not stored in bunded area isolated from site drainage system.

IBC was not labelled as to contents - **Operator to label by 07/08/20 including any others.**

ACTIONS

- Operator to label all containers used to store liquids or wastes with contents with immediate effect.
- Operator to provide NRW with proposals for remediation of cracks of impermeable pavement prior to recommencement of waste acceptance and by 31/08/20.

Advise & Guidance

The Operator must give NRW notice of planned date of recommencement of receiving wastes following cessation as per Condition 1.10.1.
