4. Details of our assessment

Thank you for your time during the inspection carried out on 03-08-20 by NRW officers. The inspection found that Minffordd was compliant with the permit conditions inspected during the visit.

A slight build-up of dust was noted on the ground from a few of the fans on the side of the building, it has been requested that this is cleared more frequently. A solution would be to

place a tray or container below the fan to catch the dust, this would enable it to be removed easily. Please advise on what method will be used.

Odour - Officers and operator discussed odour complaints. Operator clarified site had not received any complaints directly to the site. Officers explained that NRW have received several reports of odour. NRW officers have carried out unannounced visits to check odour in the vicinity of the site during this flock. They have liaised with the operator to investigate issues resulting in the site reviewing the odour management plan, site has experimented with increasing bedding material and has installed replacement fans on the older sheds. The operator carries out odour checks on and off site, it was recommended to keep a record of daily odour checks on site.

The unit is at the end of the cycle, and birds will be leaving in the next couple of days. Officers entered one of the sheds to examine the litter, it was found to be loose and friable.

Before the onsite inspection officers carried out a walk around various locations outside the site. Locations included the opposite side of the river, the lane alongside the unit, around the village and the café in front of the unit. No odours were detected in these locations. There was a gentle westerly wind during the visit.

Any compliance criteria not highlighted in the above summary should be considered as not assessed.
