4. Details of our assessment

Permit Variation V009 carried the following improvement condition which has now been evaluated

and satisfied by NRW. We confirm that IC7 has now been completed.

IC7

The Operator shall submit a written report to Natural Resources Wales for approval providing details of the fixed dust suppression system for dust control within the asphalt plant.

Within 3 months of issue of variation V009 or as otherwise agreed in writing by Natural Resources Wales.

The report shall include:

- Identification of sources to be treated.
- Technical specification of the suppression system and the area covered.
- Performance standards/guarantees.
- A proposed timetable for installation.

Harsco provided the technical data sheets for the evaluation to be completed on 5th Aug 2020 which was within the 3 month period stipulated by the permit variation issued 5th May 2020.

All technical sheet choices were submitted. NRW understand that the final decision as to which manufacturer has not yet been made, but all manufacturers comply to recognised standards.

Identification of sources within the asphalt plant have been satisfied within Harsco's EPR/TP3639BH/V009 IC7 Fixed suppression system & additional dust control measures' document.

The timetable for implementation is the 30th Sept 2020.

Fugitive dust

The plant has been operating since the granting of the permit variation V009 which included the asphalt plant into the main Celsa Meltshop permit TP3639BH. Dust suppression measures for Celsa and the plant fall under this umbrella permit and must be adhered to especially within the cross over period during May 5th when the permit was issued and Sept 30th when the suppression equipment is scheduled to be in place. As Celsa has the overall permit, the responsibility lies with Celsa to implement their Dust management plan and ensure all measures and operational techniques are employed by their workforce and their sub-contractors and partners. IC6 is in place to measure PM10's and total suspended particles (TSP) with reports submitted to NRW on a 2 monthly basis.
