4. Details of our assessment

NRW officer Phil Harper visited Green Skips (Environmental) Ltd, Plot 10, Gaerwen Industrial Estate, Gaerwen, LL60 6HR on the 3rd August 2020 at 13:30. Kevin Davies accompanied the site inspection. The purpose of the visit was to check the compliance of a statutory notice to clear inert waste.

Weather conditions were dry and sunny.

At the time of the visit the site was operational.



B4 Containment of stored materials

Segregated waste was stored in bays that have been constructed using concrete lego blocks. Bays were in good condition.

Wood waste was spilling out of the bay, it is understood that the operator had been let down by collecting services on this occasion. Wood that is spilling out of its bay in this manner presents a fire risk.



A1 Specified by permit

Permit condition A.8.2 (Detailed in working plan)

A trommel and picking line have been installed on the site. Kevin Davies informed officers that this equipment was not currently operational as the licence variation had not yet been approved.

Making reference to section 4.3 of the agreed working plan which states “The load will be sorted by hand or with a mechanical grab/bucket (on the JCB)”.

Please note that a licence variation must be approved before using the trommel and picking line.

C3 Materials Acceptance

Permit Condition A.2.1 (Appendix 1)

The site has cleared the inert waste as specified by the EPR Regulation 36 notice which was issued on the 17th June 2020 and is now within its permitted limit.



F1 Odour

No odours on site or outside of the site boundary.

F2 Noise

Site was operational during the inspection, no excessive noise.

F3 Dust/fibres/particulates and litter

No dust on site, no litter outside of the site boundary.

F4 Pests/birds and scavengers

No vermin on site.

F5 Deposits on road

No deposits or mud on the road outside the site.
