4. Details of our assessment

Stormy Down AD Facility

Annual returns report for year 2019.

EPR/AB3191FR

The site came under the regulation of the South Central Industry and waste regulation team since Oct 1st 2019 due to internal team boundary changes within NRW.

The site submitted their annual returns on-time on 30th Jan 2020. These have now been evaluated against the site permit with the following notes;

- The site processed 48,372 tonnes of solid waste in 2019, with 7,331 tonnes of liquid waste. Site permit limit is 75,000 tonnes per year. This generated 24,629 MWh of which 22,187MWh was exported to the grid.
- The flare stack was used 1.5% of the time, which is below the 10% period laid down at permit condition S3.1 note 2.
- Site drew 2,861m3 from borehole water in 2019.
- Site used 9.606MW of grid electricity which equates to 23,054MW of primary energy using the 2.4 multiplier. No Gas used.
- A1 NOx emissions to air are taken from a 1 hour average measurement once per year. The site was under its 500mg/m3 limit at 495mg/m3 with an uncertainty of 22%. The NOx from site needs close management to ensure this does not breach limits for 2020. A2 stack was also high at 485mg/m3 with the same parameters of 500mg/m3 limit and 22% uncertainty.
- SOx, nmVOC, VOC, and CO were all well under the permit limits for A1 and A2.

Q4 2019 Quarterly waste return assessment.

Additionally, the site continues to submit waste returns on time. Quarter 4 (Oct-Dec 2019) was checked for permitted tonnage limits and permitted EWC codes and found to be fully compliant.

Q1 2020 Quarterly Waste return.

Site continues to use the EWC codes it is permitted to use. 18,103.6 tonnes have been accepted in Q1 2020.
