This Compliance Assessment Report has been issued as a record that Natural Resources Wales has completed its assessment of the Hydrogeological Risk Assessment (HRA) 2016, the HRA 2016 Addendum, and supporting information. Natural Resources Wales accepts these documents and is now satisfied that IPC1 of the Environmental Permit has now been determined.

Following the initial submission of the HRA 2016 (01/11/2016), Natural Resources Wales assessed the document and made requests for further information. This information has been provided by Neath-Port Talbot Waste Management Co. Ltd.
