4. Details of our assessment

ALUK are making good progress in completing the actions raised in CAR_NRW0036841 and are keeping Natural Resources Wales (NRW) regularly updated.

Action 2: Develop and implement a procedure to prevent any effluent containing determinands at or above the permitted ELVs from being discharged to sewer. Send a copy of the procedure to NRW by 28th August 2020.

ALUK have developed an interim procedure that involves diluting the discharge. This is only acceptable in the very short term. However, their chemical supplier has audited the effluent treatment plant (ETP) and identified a simple modification that would return the liquid output from the filter press to the ETP to prevent sewer emissions breaching the permitted ELVs.

This action remains open. The completion date is now 4th September 2020.

Action 4: Provide NRW with evidence that the relevant personnel have been trained in the procedure for preventing discharge of non-conforming effluent to sewer by 25th September 2020.

The date for completion and recording of training in this procedure remains as 25th September 2020.

Action 3: Provide NRW with evidence that the monitoring and reporting training has been completed by 28th August 2020.

Training records have been seen. **Action 3 is complete.**

Action 1: Discuss the technical and economic feasibility of installing a SCADA system with NRW.

ALUK have identified a more cost effective way for the in-line aluminium monitor to raise alarms and communicate results automatically with their existing systems. A SCADA system is the ideal, but not strictly necessary in this case, as long as the proposed system provides data in a timely manner.

NRW appreciate the time and effort that the team at ALUK are dedicating to improving compliance with their permit conditions.
