On 14 August 2020 NRW were made aware through an update on Companies House that

EPS Materials Recovery Ltd had gone into administration on 17 July 2020.

G4: Reporting and Notification to Natural Resources Wales - CAT 4 - Permit condition 4.3.4 (b):

You have been given a Category 4 breach of the above permit condition as NRW was not informed of the company taking steps to enter into administration with 14 days of the occurrence. This has been scored as a Category 4 as it has no environmental impact.

Permit condition 4.3.4 (b) states:

Natural Resources Wales shall be notified within 14 days of the occurrence of the following matters, except where such disclosure is prohibited by Stock Exchange rules:

(b) any steps taken with a view to the operator going into administration, entering into a company voluntary arrangement or being wound up.

No further action is required following this breach of permit conditions.

Any compliance criteria not highlighted in the above summary should be considered as not assessed.
