3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

Root ingress upstream caused a blockage that flooded the internal of a property. Whilst trying to unblock the wipes and rags held in the root ingress dislodged heading down the sewer network causing another blockage. This secondary blockage caused a discharge through a CSO that had a permit only to discharge in storm conditions. Whilst trying to gain access to the CSO the locks had been glued and waste tipped on the manhole, causing a longer impact on the pollution.

Whilst reviewing the photos I believe there was a minor impact.

Third part claim has been assessed in line with 16.02 guidance, Pollution could not have been anticipated (Random act of vandalism and unknown root ingress), prevented (Not reasonable for DCWW to assume CSO's to be vandalised), or mitigated by reasonable intervention of the company (because random act of vandalism team could not be on scene straight away/ no telemetry) and is not a common feature of water industry operations (i.e CSO's are not supposed to function like that and many other CSO's function as intended). Third party responsibility as incident unanticipated and unforeseeable cases of vandalism.

Will issue advice and guidance through email, Stating that DCWW need to regularly inspect and maintain their sewage network. As well as a review of theirs systems to try and catch any debris whilst unblocking the effected area, not to cause a secondary blockage and cause further pollution.
