4. Details of our assessment

Compliance Assessment Report – Treorchy Community Recycling Centre (EPR-QP3799FR)

Officer David WARWICK-BROWN inspected Treorchy Community Recycling Centre,

11:30-11:45, on 28/08/2020 to assess the sites suitability for surrender. The weather was sunny & dry.

The site was last inspected by NRW on 20/02/2018, when the surrender of the permit was discussed with the operator – it was agreed that the site meets the requirements for a low risk surrender, and the site was clear and secured. At the time of this last inspection it was confirmed that the site had been non-operational for numerous years.

However, during this inspection there were several piles of green waste, wood, soil and stone on site, including a skip filled halfway with green waste. The gates remained secured, yet it was possible to walk around the site’s perimeter – the following photos were taken, showing the waste currently remaining on site:

It is evident that the permit is **not appropriate** for surrender until this waste has been removed.

Action: Please remove this waste to proceed with the surrender application.

In terms of infrastructure, the impermeable surface appeared to be in an appropriate condition, and no drainage system was visible on site – it seemed that drainage system for the site consisted of the mains sewer outside of the site boundary on the western edge of the perimeter, which appeared to be in a satisfactory condition during the inspection.

However, the suitability of these aspects for surrendering the permit cannot be confirmed until the site is empty.
