4. Details of our assessment

A visit took place on the 10th August, 2020 by Phil Harper. The purpose of the visit was to inspect the site in relation to the surrender of Permit ZP3097ET (EAWML 102879). Also present was Dewi Jones, Operator.

Prior to the visit, all waste transfer notes had been received. All waste materials accepted was as specified by the permit.

The area where the waste had been deposited has since been covered with a building and land used by the farmer for agricultural purposes. Due to the change in land use, the operator had decided to surrender the permit.

The inspecting officer had no issues relating to the surrender of the permit.

The attached photos, 1 through 4, taken by Phil Harper at time of specified site visit shows where waste had previously been deposited. A building has now been constructed on the land and is now being used for agricultural purposes.
