4. Details of our assessment

This was a desk-top based inspection carried out on Monday 10th August 2020 by Natural Resources Wales officer Daniel Grant (Hazardous Waste Regulation Officer). During this inspection waste returns submitted over the past year and the site's TCM status were reviewed.

Discussions initially took place over the phone with Jayne Sutcliffe on Monday 29th June 2020.

Waste returns

Waste returns from Quarter 1-4 in 2019 and Quarter 1 2020 were reviewed.

It was explained that the latest waste return on NRW's electronic filing system was from Quarter 3 2019, therefore, it appeared that waste returns from Quarter 4 2019 and Q1 2020 were late. However, this was rectified as Jayne explained that these returns had been sent on time to the waste returns inbox. This was raised with the "waste returns" department within NRW and we were able to find that the waste returns had been sent on time- but incorrectly uploaded to the system.

No issues were found with the content of the waste returns. Thank you for your compliance with this condition.

TCM

The current TCM duties for the site are being provided by Jayne Sutcliffe until the 09th July 2021. The certificate was sent as evidence of this competency on the 30th June 2020. Thank you for your compliance here as well.

EMS

An updated EMS was initially requested on the 30th June and submitted to NRW on the 21st August 2020. Thank you for submitting these documents. Your EMS was not reviewed for this inspection. Your site has been handed over to a different regulating officer who will likely review these documents and complete a separate CAR form for this in the near future.
