## 4. Details of our assessment

Newport Wafer Fab (NWF) were issued with a permit variation on 14<sup>th</sup> September 2020. NWF wish to confirm that their existing or proposed arrangements will comply with three of these permit conditions. This CAR is to confirm that Natural Resources Wales (NRW) will accept these measures as compliant.

Permit Condition 1.2 Energy Efficiency states -

"1.2.1 The operator shall:

- (a) take appropriate measures to ensure that energy is used efficiently in the activities;
- (b) review and record at least every four years whether there are suitable opportunities to improve the energy efficiency of the activities; and
- (c) take any further appropriate measures identified by a review."

NWF currently hold ISO50001:2018 accreditation for its energy management systems. NRW agree that as long as NWF maintain this accreditation they will be complying with PC 1.2 without the need for further reporting to NRW.

**Action: Send copies of the results of any external compliance audits and updated certificates to NRW to confirm ISO50001 accreditation is being maintained.**

Permit Condition 3.5.4 (3.5 Monitoring) states -

"Permanent means of access shall be provided to enable sampling/monitoring to be carried out in relation to the emission points specified in Schedule 3 Tables S3.1, S3.2 and S3.3 unless otherwise agreed in writing by Natural Resources Wales.

NRW agree that NWF and their monitoring contractor can erect temporary scaffolding in order to carry out the three yearly monitoring of emission point A15, emissions from the combined heat and power unit.

**Action: The monitoring contractor should submit a site method statement to NWF demonstrating compliance with Technical Guidance Note (TGN) M1 Sampling requirements for stack emission monitoring and TGN M5 Monitoring stack gas emissions for medium combustion plant and specified generators. This method statement should be available for NRW to inspect when required.**

Permit Condition 3.5.5 (3.5 Monitoring) states -

"For the following activity, reference A15 in Schedule 3, Table S3.1 the first monitoring measurements will be carried out within four months of the issue date of this permit or the date when the MCP is first put into operation whichever is later."

NWF submitted monitoring data as part of their application for a variation to their existing permit.

**NRW consider that this condition has been met and do not require NWF to submit further monitoring data.**
