### 4. Details of our assessment

Ashley Collins, Powys County Council - Waste and Recycling Manager contacted Liz Park in July 2020 to discuss reports of odour emissions they had received from the Rhayader Depot. Reports are now being made directly to NRW. NRW received two complaints of odour as follows:

WIRS 2005204 – Received on 21/07/2020 at 16:50.

Report of odour from the Rhayader depot for the last five years.

WIRS 2006471 – Received 05/09/2020 at 18:30

Complaint of strong 'refuse' odour that has been present all day.

Liz Park, a Waste Regulation Officer attended the site on 20 August 2020 following the first report. At the time of the visit the wind was swirling. Liz did not enter the site but stood by the gates on Station road. She detected the very faintest of odour though not enough to substantiate an incident.

Ashley Collins and Nigel Hicks (Technically Competent Manager) were asked to investigate as to what may have been a cause for the odour complaint received on 05/09/2020 and provide a brief written report.

A detailed reply was received from Ashley Collins. Odour monitoring has increased but no noticeable odour has been detected by various staff members of Powys County Council. A small amount of refuse waste was being stored on site on Saturday 05/09/2020, but the doors remained closed all day, and no waste was loaded/ unloaded, therefore it is unclear as to how this could be the source of the odour. Ashley mentioned that there was a market on Friday and that this was being cleaned on Saturday. This could be an odour source though the report is of refuse. It is noted that refuse has only been stored on the site regularly in the last 8 months.

This situation will be continued to be monitored. Liz Park has requested that an updated version of the Odour Management Plan is provided.
