4. Details of our assessment

Thank you for your time during the pollution prevention inspection at Stud Farm carried out

by Natural Resources Wales (NRW) officers on the 8th September 2020 as part of a River Lugg catchment initiative.

Officers did not carry out a full compliance inspection of the unit. The visit covered a yard inspection, site drainage, clean and dirty water separation, fuel oil and chemical storage, feed silos, accident management plan, manure management, water abstraction and a walk over of the site.

On inspection of the fuel tank it was noted that the bund did not appear to be large enough to provide at least 110% of the volume of the fuel tank. To ensure you are legally compliant please can you check if the containment does meet the requirements - The Control of Pollution (Oil Storage) (Wales) Regulations 2016. - If the secondary containment does not meet the requirements, please ensure action is taken to become compliant with the regulation. please can you let me know the outcome by the **16/10/20**.

A slight build-up of dust was noted on the ground from a few of the fans on the side of the buildings. We discussed ways to remove the dust, particularly beside House 2 (as noted in the permit) nearest the watercourse. Please ensure that regular inspections of the fans are carried out, dust is removed frequently and any dust or runoff is not allowed to enter surface water drainage and the nearby watercourse. Please also ensure any runoff from dust accumulating in the concrete channels by the side of some of the sheds must be diverted to dirty water.

Any compliance criteria not highlighted in the above summary should be considered as not assessed.
