4. Details of our assessment

On 08/09/2020, Natural Resources Wales (NRW) officers conducted a pollution prevention visit at Warren Farm as part of a River Lugg catchment initiative. The inspection included outside pollution prevention elements only and did not cover all the usual compliance

assessment of the site against the installation permit. We thank you for your time in showing us around. During our visit we discussed yard and shed drainage, clean and dirty water separation, litter export, chemical storage, oil storage, accident management, foodstuff storage etc.

It was noted whilst at the site that the water supply for the site is sourced from a borehole with a backup of mains water available. We have checked our internal records and cannot find an abstraction license registered for this unit. You must have an abstraction licence if you take at least 20 cubic meters a day of water from an inland water or from groundwater, unless it is exempt from licensing. Please be aware that if you abstract water without a license, when one is needed, you are committing an offence and we may take enforcement action against you.
