Background;

Biotage operate under permit EPR-DP3832EF. Previous CAR form NRW0036777 detailed one action as follows;

Action 1 Biotage 10th July 2020: *Make proposals of the actions you propose to take to deal with ST NOx emissions at A3 and ST HCl emissions at A1. Provide a timeline for implementation (can be indicative at this stage and finalised by agreement with NRW). The proposals may be affected by your planned extension.*

Due: 30th September 2020.

Current status (as of 23rd September 2020);

A meeting (online) was requested by Biotage with IJ (Regulator for NRW), this took place on 15th September 2020. Biotage explained how they would probably need to engage with a service provider to give detailed modelling and it was agreed at the meeting that a proposal would be forthcoming ahead of the 30th September deadline.

A response to Action 1 was received by email to NRW on 22nd September 2020 and assessed IJ for NRW.

Outcome;

The response, proposed dates and actions being taken by Biotage are accepted by NRW.

NRW look forward to receiving the subsequent information by the 30th October 2020 and 20th November 2020 dates proposed in relation to the points highlighted in the letter dated 22nd September 2020.

Please note the enforcement action section of the CAR form is set at 'No further action' in relation to the current stage of the process of improvements. This could change depending on the outcome.
