NRW received Poeton's Waste Minimisation Report for 2019 as part of permit condition 2.4.1.2.

NRW are pleased to see the proportion of waste going to landfill significantly reduced. Both the actual tonnage and the waste per employee have been reduced in 2019.

The Carbon Dioxide produced for 2019 has increased, however, the number of employees and subsequent production rate have increased.

As stated in the report the water usage in 2019 has increased substantially. Poeton states it is a result of a large increase in turnover of work and a possible error on the water meter. Please investigate this and inform NRW of your findings.

The report is accepted.

S1 form for the discharges to sewer was received on the 24th September 2020. All results were within the associated emission Limit Values.

Action: Please can you explain why the Accreditation/Certification sections have been left blank?

The form was received past the 28day deadline as stated in permit condition 4.1.2.4. Poeton had to be reminded to send it. NRW take a proportionate approach to non-compliances relating to monitoring & reporting conditions during the pandemic. We will record this breach as a category 4 non-compliance. We will then suspend the score immediately to take account of your Covid-19 extenuating circumstances.
