## 4. Details of our assessment

Thank you for your time during the pollution prevention inspection at Nant Y Cordy Poultry Farm carried out by Natural Resources Wales (NRW) officers on the 8th September 2020 as part of a River Lugg catchment initiative.

Officers did not carry out a full compliance inspection of the unit. The visit covered a yard inspection, site drainage, clean and dirty water separation, fuel oil and chemical storage, feed silos, accident management plan, manure management, water abstraction and a walk over of the site.

On inspection of the fuel tank it was noted that the bund did not appear to be large enough to provide at least 110% of the volume of the fuel tank. To ensure you are legally compliant please can you check if the containment does meet the requirements - The Control of Pollution (Oil Storage) (Wales) Regulations 2016. - If the secondary containment does not meet the requirements, please ensure action is taken to become compliant with the regulations. Please can you let me know the outcome by the **16/10/20**.

We discussed cleaning out of the sheds at turnaround time. It was noted that the yard is on a slight slope we discussed the management of the drainage on the yard and asked that the contaminated water is contained on site. You advised that all the runoff water is directed and contained in the dirty water tank.
