As per the Pre-notification form, spreading notifications periods should not be longer than 10 days from the expected start date. The above notification dates state that spreading will take place over an extended period of time, therefore this is a breach of condition 4.3.4 of your standard rules permit. As a result of this permit breach a CCS score of 4 has been applied.

Permit Condition 4.3.4 - Reporting and Notifications - CCS Cat 4

Spreading notification periods are considerably longer than the 10 days allowed on the Pre-notification form.

Action Required:

You must re-submit a Pre-Notification form for all deployments noted above with new start and end spreading dates as detailed on the Pre-notification form. Should spreading stop for more than 7 days, a new Pre-Notification form is required. Please take into account that it is acceptable to send in several Pre-Notification forms per deployment.
