4. Details of our assessment

This was a pre-arranged inspection carried out by Senior Environment Officer Steven

White and Environment Officer Boguslawa Pierzchala following the relaxation of the NRW fieldwork guidelines during the ongoing Covid-19 crisis. Officers met with Mike Jackson on site.

The site is currently going through a considerable scheme of renovation with areas of hardcore being concreted and future improvements (new ELV depollution building) in discussion.

The following observations were made during the inspection and were brought to the attention of the site manager and Mike Jackson during the visit (see accompanying pictures):

- There were a large number of tyres on site, these looked as though they were stacked ready for collection; this was confirmed on site.
- An engine block was observed in the yard and not under covered storage; this was to be moved under weatherproof covering at the earliest opportunity
- There was a spill of fluid emanating from the depollution area; spill kit was in the process of being applied as officers left site.
- Officers checked a number of vehicles for depollution, one had fluid (coolant) still in the engine block

Actions from site visit

- All oily parts/engine blocks etc must be stored in a weatherproof storage container/building
- All spills must be cleared up as soon as possible
- All vehicles must be fully depolluted prior to storage on the hardstanding area of the yard.

These were brought to the attention of Mike Jackson during the visit.

Officers discussed the ELV industry and its coping with the ongoing Covid-19 crisis, current market trends and future site improvements with Mike Jackson and then left site.
