4. Details of our assessment

This was a pre-arranged inspection following the relaxation of the NRW fieldwork guidelines with regards to site inspections, the visit was carried out by Senior Environment Officer Steven White and Environment Officer Boguslawka Pierzchala who met with TCM Stuart Butterworth on site.

On arrival it was observed that there was a large amount of metals on site at the time of the

inspection with piles estimated at <10m high (see photos below), the piles were below the height of the quarry walls and looked stable.

There was no activity on site during the visit, depollution of ELV does not take place and the garage on site is for the maintenance of vehicles/machinery from the caravan park business. There were crushed and stacked depolluted ELV on site; with no signs of spills or contamination of the hardcore ground (see photo below).
