4. Details of our assessment

This was a pre-arranged site visit; in attendance was Senior Environment Officer Steven White and Environment Officer Karl Attwood

Upon signing in at the site we began our site inspection at the entrance of the site. Oakenholt is a new site with good security measures in place. There are several security cameras located around the site, security fences and gated entrance which is locked in the evenings. The entrance was clear from debris, mesh was attached to the security fences in addition as an aid to catch materials that will have been blown from the skips. Some polystyrene was observed blown off a nearby skip, this was brought to the attention of site operatives for collection as part of the daily clean up (see photos below). Road markings were clear leading up to the parking bays located directly in front of the skips.

The site is set out in a two-tier system that gives good access for both public and contractors to collect the full skips.

Continuing around the perimeter of the site, we were able to see that the designated recycle skips were maintained well with no clear visible damage. The large skips located behind where vehicles park were kept clear from debris, walkways were clear and no hazards were noted. Each skip clearly indicated what materials were allowed in each skip and they all appeared to have the correct materials inside.

Batteries were stored in suitable containers with weatherproof covering and paint tins were also stored in suitable weatherproof containers (see photos below).
