4. Details of our assessment

NRW were provided with a Schedule 5 Notification on 21st August 2020 in respect of raised NOx levels identified on the Boiler 16 release point on 20th August 2020. A follow up Part B was provided on 22nd September 2020, an amended version was provided on 24th September 2020.

It had been identified that a water injection unit was not being activated by the main control

system as a result of a communications error. As a direct result of this raised NOx levels of ~85mg/Nm3 were being recorded versus the limit of 75mg/Nm3.

For NOx measurements it is normal for NRW to apply a confidence interval value of 20%. This is to account for the measurement uncertainty and be confident that measured values are indicative of an ELV exceedance. In this instance application of this factor leads to a corrected NOx value of 68mg/Nm3 which is below the ELV. Therefore in this instance a non-compliance has not been recorded.

Solutia have implemented actions to minimise the chances of reoccurrence. These include additions to the daily checklist and investigating the feasibility of additional process safeguards with the GT manufacturer. NRW accepts this as a proportionate response to an issue that could not have reasonably been foreseen.
