Incident reported to NRW during extended dry weather period that was formally called a developing drought. WIRS 1804241. Sewage fungus found on rocks of river bed immediately downstream of the final effluent outfall. Afon Seiont was exceptionally low. Sewage works was compliant with permit conditions. WIRS classed as low level to water, but as compliant with permit.

Discussions took place with Dwr Cymru regarding brushing down stones in river where possible.

Various meetings were held with Dwr Cymru regarding dealing with drought conditions.

In terms of strategic planning, the site needs to be highlighted as one where reports of pollution by members of the public are likely during very low flow conditions.
