Environment officers Nessa Dearle and Kelly Sherratt attended site on the 21st of September 2017, to complete a routine site inspection. The weather was mild and dry at the time of inspection. Thank you for taking the time to show us around site. In general, the site appeared well managed at the time of the inspection and no breaches against your permit were recorded while on site.

However, while on site, we observed some oil spills near the oil storage and refuelling area. The environmental management system and risk assessments for the site outline that procedures should be in place to manage spills on site. Please ensure that spill kits are in place and used on site by staff in the case of spills at the refuelling bay. All oils that are stored in this area should also be stored in containers with secondary containment.

Thank you for showing us an up to date WAMITAB certificate for the site operator. We do not currently have a copy of this certificate on our system, could you please send an electronic copy of this certificate to the NRW.
