3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we are issuing you with a warning for the non-compliance recorded above. Warnings may influence future enforcement response for continued or further non-compliance.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

Look up table (LUT) number of allowed exceedances (2 allowed) have not been met, as a

third exceedance occurred in the rolling year.

Waiver claim submitted by DCWW but NRW has rejected as it does not follow the types of waiver that NRW are allowed to consider, as cited in the Environmental Permitting Regs 2016 (for example adverse weather, third party actions), giving us no choice but to reject it.

The LUT failure would normally attract an enforcement level higher than a warning but in coming to an informed decision, we have taken into account DCWW's continued efforts to maintain this remote site following the access tunnel becoming dangerous and inaccessible; a contingency to handle sludge better (which is thought to be the main root cause of sanitary permit limit exceedances); DCWW's continued efforts to take forward proposal for new treatment works access track on other land and delays in ecological surveys (missing tight survey windows) caused by COVID-related delays.
