4. Details of our assessment

This was a pre-arranged visit to Moel Y Faen Quarry to discuss the ongoing regeneration process on site. Senior Environment Officer Steven White met with Ian Hughes (Environment Officer (Special Sites) NRW), Chris Bennett (Cambrian Ltd), Stephen Blunt (Richards, Moorehead & Laing Ltd) and Neil Parry (Minerals and Planning, Flintshire Council). There were no operations going on during the site visit, weather was wet with lots of standing water and runoff observed (however none was observed affecting off-site)

Whilst on site we discussed the ongoing regeneration process to get the quarry back to as close as natural state as possible, the following were discussed in detail:

- Heather seeding,
- Site drainage,
- Waste movements and material use,
- Vehicle access,
- Site security and public access
- Void infilling ('Blue Lagoon')
- Site landscaping

No concerns were raised regarding the waste operations observed on site.

A waste return audit was carried out in June 2020; no issues were found during this audit.
