4. Details of our assessment

This was a pre-arranged inspection to discuss the forthcoming surrender of the site permit and inspect the site to ascertain if it is ready for surrender. Senior Environment Officer Steven White and Environment officer Sarah Walton met with Director Tony Williams who accompanied officers throughout.

The site had been previously emptied of waste material (~July 2020) and no more waste had been imported following this date. On arrival at the Inertia site it was observed that the area where the water transfer station had been had already begun to be excavated by the quarry owner for the quarry material. There were no waste materials on site during the visit, there were a lot of vehicle movements observed (wagons, quarry machinery) and some mud was observed on the access road, however these observations were all in relation to the work going on in the main quarry (regulated by the Local Authority) and not the Inertia site.

As part of the surrender process a Site Condition Report would be required to be completed (further guidance on this has been sent separately) and a paperwork audit will be carried out on the waste accepted and WRAP Quality Protocol material leaving the site. Further correspondence will be sent with regards to the scope of the audit and the information required.

In it's current state (on 28-09-2020) the site is suitable for surrender.
