Complaint received from a member of the public that Penygroes CSO No.2 was discharging discoloured effluent into Afon Llyfni at 17.00 on the 24th of September. An Early Warning was issued by Dwr Cymru. Incident recorded on WIRS as incident number 1906434.

Photographs were provided by the member of the public and these showed the Afon Llyfni to have been discoloured by a discharge from the CSO.

Investigations by Dwr Cymru have concluded that the discharge was caused by an illegal discharge to sewer at a manhole on Penygroes Industrial Estate at a location described as the hammer head. The discharge to sewer then caused a discharge down the CSO. Enquiries by Dwr Cymru failed to identify who caused this, it's believed to have been due to a tanker load of material being dumped. The location appears ideal for fly-tipping of wastes in general, and liquid waste too.

Following discussions with Dwr Cymru, the manhole in question is to be welded down to prevent a further incident from happening. Natural Resources Wales have provided a no fly-tipping sign to be installed at the site.

In light of this incident and a similar one at Dolwyddelan STW a few months earlier, Natural Resources Wales has to ask if Dwr Cymru are aware of any similar incidents regarding tankers dumping their loads into the sewer system? Are there any other sites where this is a particular risk? What action is being taken to prevent further such incidents? Is any enforcement action underway?

Please note that Natural Resources Wales could decline to accept a 3rd party incident claim where Dwr Cymru are aware of such dumping of liquid waste and no action taken.
