4. Details of our assessment

On 27th October 2020 Natural Resources Wales (NRW) received a Schedule 5 Notification from AIUK to inform them that the emission limit value (ELV) for aluminium emissions to sewer had been breached on 27th October 2020. The measured concentration was 3.1mg/L; the ELV is 2mg/L. The effluent treatment plant was operating but not discharging to sewer at the time. A sample taken 18 minutes later showed that the concentration had reduced to 1.6mg/L.

The high reading seems to be related to an on-going problem with airlocks in the in-line aluminium monitor. This should be addressed when the monitor is relocated as part of the installation of the MCERTS flow meter. This action has already been raised, see CAR_NRW0036963 Action G1, and is due to be completed on 24th December 2020.

AIUK have developed an interim solution which should be installed by 30th October 2020. This is designed to ensure that the sampling tube is always submerged to a suitable depth.

At the moment, NRW do not propose to take further action but may do so should circumstances change.
