4. Details of our assessment

Site was visited in a joint inspection with the Fire Rescue Service (FRS).

A Covid-19 pre-visit Risk assessment was carried out.

NRW officer met with Philip Price and Stuart from the FRS. The FRS officers were present as they have been asked to provide comment on the Fire Prevention and Mitigation Plan (FPMP) as part of the ongoing permit variation application process.

Nening Jones was unavailable during the visit so he had arranged a member of staff to open the site. There was no other staff on site at time of visit and it was locked up after our visit.

The site was clean and tidy and well organised.

Depollution:

There was only one ELV in the depollution treatment shed but no depollution of ELVs was taking place at time of visit and officers were unable to check the process for compliance. A couple of the depolluted ELV's on the pad were inspected for evidence of depollution and they had had the engines removed and fluids drained.

Waste storage:

All onsite waste was stored on the impermeable pad. A couple of ELV's were however found to be stored off site and outside the permit boundary. This is a breach of Permit condition 2.4 and has been recorded as a **Category 3 non-compliance**. These ELV'S must be brought onto the site and stored or treated in line with your permit conditions.

Legal status of this report
