4. Details of our assessment

On 09 September 2020 Derwen Aggregates Ltd site was inspected by Sally Wakeford and James Kinkead.

This was the first inspection since Covid-19 lockdown and was a simple check on the site to gauge general compliance with the permit.

A walk around the site was undertaken.

Maintenance was being undertaken on the washplant at the time of the inspection, and therefore the stockpile of materials to put through appeared slightly larger than usual.

The site appeared well organised and to have good segregation of materials.

The stockpile of fines from the washplant appeared to be being managed well.

During the next inspection I would like to discuss the stock rotation plan which was submitted to understand how this is currently being implemented to ensure wastes are removed from site in a suitable time frame.
