OSM sample results came back with BOD result of 28mg/l as compared to permit limit of 25mg/l. This result was challenged by Dwr Cymru as not being representative due to contamination etc. This claim was considered by Natural Resources Wales but formally rejected on the grounds that there wasn't sufficient evidence to confirm chemical interference of the analytical method.
