On the 23/04/2018, DCWW's sample of Llidiardau Water Treatment Work's discharge failed to meet the conditions outlined in discharge permit CG0354201.

The permit conditions that failed was condition 3.2.1. wherein it states that concentrations outlined in schedule 3 should not be exceeded. There were two instances of this non-compliance.

The parameters that were exceeded was aluminium and pH. the consent limit is 1mg/l and pH between 6-9, which was breached with a 1.11mg/l and pH 9.4 failure, respectively.

DCWW offered this explanation.

The root-cause of the incident was determined to be miscommunication between DCWW and the contractor and the parameter breaches of pH 9.4 and Aluminium 1.11 mg/L on 23/04/2018 are associated with the same event occurring on site.

During cleaning, the analyser discharge is isolated to collect the waste water from the analyser. This analyser water is high pH water. The isolated discharge that has been collected is then removed via a pump and tanker, to be disposed of off-site. DCWW found that the cleaning contractor had begun cleaning work before the Operator was made aware to divert the analyser discharge to be collected.

DCWW now emphasise the importance of communication to ensure that the analyser discharge is not permitted to enter the environment during cleaning.

They have made improvements to their procedures, which include information on the discharge consent being included in the site induction and in the environmental impact in risk assessments before any work is undertaken.

They are also reviewing the drainage network of the site to ensure no dirty water is discharged.

They have sourced a new Aluminium analyser, and they have streamlined and increased the operational self-monitoring frequency samples taken to one a week to ensure compliance and put in isolation and escalation procedures should sample results show elevated levels.
