NRW were informed by email on 30th October, 2020, that it was necessary for Knauf Insulation to shut down the EP unit in order to complete essential preventative maintenance work. This would take place over the period Monday 2nd November at 14:00 until 10:00 Wednesday 4th November.

NRW accept that this course of action is necessary and in future request that where

possible, more notice be given when planned maintenance is scheduled.

Knauf Insulation must take all possible measures to minimise emissions during this period. NRW must be informed of any complaints received during the shut down period and when normal EP operation is resumed.
