inspection.

This was an announced inspection due to the current Covid 19 restrictions to ensure safety of all people involved. The officers were met by David Chaloner who accompanied officers throughout the inspection.

The site was clean and well run with the documents requested by PC Lloyd all in order. The site is being drained to an interceptor which is being cleaned annually.

The site is currently undergoing some improvement with hardstanding areas being concreted.

The batteries and lead were stored securely indoors.
