4. Details of our assessment

Routine inspection

Weather: overcast raining

The effluent enters the works through the intake and passes through screens. Rags are removed by archimedes screws and deposited in skips. The storm outlet was clear, and no effluent was discharging to storm at the time of the inspection. The effluent then passed to

PSTs and from there discharged to filter beds before final treatment in the humus tanks.

The works was refurbished during 2018/19. The medium in the filter beds was replaced and a new storm tanks and humus tanks installed.

The onsite records were up to date

The works is well maintained and operating in accordance with the permit.
