C1 Continued Competency- WAMITAB

Natural Resources Wales has received evidence of the WAMITAB qualification for James Hogan who is the Technically Competent Manager at Hogan Aggregates Ltd for operations at Caer Glaw Quarry permit no. EPR:DB3735RP with thanks.

No issues have been noted.

G4 Reporting and Notification to Natural Resources Wales

The WAMITAB certificate for Jamie Hogan expired during the Covid 19 pandemic. Due to the closure of test centres, it has been difficult for operators to renew their ongoing competency. NRW has released regulatory position documents stating that during expiration of WAMITAB certification will not constitute as a breach during Covid 19 restrictions. However, operators were required to notify NRW as soon as compliance issues became apparent.

This was highlighted in an email was sent to the operator on the 6th April 2020 in response to the Covid 19 pandemic.

Failure to notify has resulted in a **Category 4 permit breach** with respect to condition 4.2.1 The operator shall send all reports and notifications required by these standard rules to Natural Resources Wales using the contact details supplied in writing by Natural Resources Wales.
