Introduction

This inspection was conducted in response to an incident that was reported to NRW by a member of the public. NRW received a call on 3rd January 2018 claiming that there were issues at the community recycling centre such as oil/paint spillages and windswept waste and litter.

Senior Environment Officer Adam Ward attended the permitted facility at approximately 10:30 on 4th January 2018 and met with Ashley Davies (Amgen) and Steven Scorey (Amgen). Having made a brief assessment upon entering the site, it appeared that the facility was very well managed with excellent infrastructure.

Amgen staff proceeded to demonstrate various waste storage areas across the facility, as well as the sealed drainage system. I did not witness any windswept materials and there was no evidence of any spillages. No non-compliance with the permits were witnessed at the time of the inspection.

Environment Management System (EMS)

At the time of the inspection, there were strong winds at the site and it is likely that some litter could leave site in certain circumstances. It is therefore important that daily checks are made at the site perimeter to ensure any windswept litter is cleaned up in a timely manner. This is reflected in your written procedures and Section 3 of your EMS details how the risk of windswept litter is controlled.

Technically Competent Management (TCM)

Section 4.2 of your EMS details information about the TCM for Amgen sites but does not provide details of the actual TCM. Amgen staff stated that the nominated person was Julian Davies, but it would be useful for

you to provide details of any nominated person(s) in the EMS, including their specific WAMITAB Qualifications and the dates for Continuing Competency. This will with your regulatory officer's assessments at future inspections.
