Site inspection to assess the information provided by the operator in closure report number 3031-CAU-XX-XX-RP-V-0304.AO-C3 dated November 2017. Weather conditions fine, dry and warm.

b2) Infrastructure: closure and decommissioning

During the visit there was no visible evidence of slope instability or evidence of dips or hollows or standing water on the restored surface.

Some of the monitoring boreholes along the public footpath which runs parallel to Burntwood Road to the east of the site were checked. The cover and lock were missing from the 7th borehole along the path - there was no label to identify the borehole number. The lock was also missing from the borehole labelled BH11 (though this may actually be BH1.1). Groundwater borehole GW6 was not locked. Monitoring boreholes should be inspected for damage each time they are monitored or sampled in accordance with the closure report. Any damage noted should be repaired within a reasonable timescale.

Additionally, some of covers to the on-site gas and leachate management chambers were not locked. As the site is accessible to the public it is especially important that monitoring boreholes and on-site gas and leachate management chambers are kept secure to prevent damage to the site infrastructure or risk to public health.

ACTION: Monitoring boreholes and on-site gas and leachate management chambers should be inspected and any missing or broken locks or covers should be replaced.

The landfill site is considered to be in a suitable condition for definite closure to apply. During the aftercare period the site and infrastructure should be managed, monitored and maintained in accordance with the procedures and action plans contained in the closure report referred to above.
