Routine unannounced inspection carried out by new site regulating officer Rhys Thomas. Accompanied during the visit by Mike Groves.

Weather was dry and overcast at time of inspection, however ground conditions were wet as it had rained earlier in the day. Site was busy during the visit with materials being processed on site and materials being accepted and removed.

A site walkover was undertaken and the Officer was given an introduction to operations on site. All materials on site were separated into clearly defined and labelled stockpiles, organised into different grading of material. All material on site appeared to be compliant with waste acceptance criteria. Operations on site appeared organised and well managed. Site surfaces were in good condition and activities were not giving rise to any amenity issues.

Officer proceeded to site office where the system for documenting incoming and outgoing material was explained. Also discussed record keeping and viewed the process for recording daily site checks. All documentation and record keeping appear to be in good order.

No non-compliances have been recorded during this inspection.
