Environment officer Nessa Dearle visited site on the 19th of January 2018 to assess compliance with your environmental permit. The weather was cold and dry at the time of inspection and waste was being accepted on site. I was shown around site by TCM Paul Huxtable and owner Carlos Giles.

Thank you for taking the time to show me around site. No breaches were scored during this visit; however, some minor management issues were noted. Advice and guidance is outlined below.

Notes

As discussed our focus has recently been directed towards fire prevention and mitigation at waste sites. Fire prevention and mitigation plans have been applied to all relevant standard rules waste permits, with phased implementation planned for bespoke permits.

On inspection of your environmental management system (EMS), it was noted that your EMS was last revised in 2013 and could benefit from an update. The EMS contains limited information on tyres storage methods. This update should include fire prevention and mitigation measures. It is best practice to incorporate fire breaks into your tyre storage. As such I request that you include a section in your EMS, to outline how fire risks are managed on site. I have attached a copy of our fire prevention and mitigation plan guidance below, to assist.
