G4 Reporting and Notification to Natural Resources Wales

The WAMITAB certificate for Daniel Maccabe has expired during the Covid 19 pandemic. Due to the closure of test centres, it has been difficult for operators to renew their ongoing competency. NRW has released regulatory position documents stating that during expiration of WAMITAB certification will not constitute as a breach during Covid 19 restrictions. However, operators were required to notify NRW as soon as compliance issues became apparent.

This was highlighted in an email was sent to the operator on the 2nd April 2020 in response to the Covid 19 pandemic.

Failure to notify has resulted in a **Category 4 permit breach** with respect to condition 1.11.1a Except where otherwise specified, all notifications and submissions to the Agency under the requirements of these licence conditions shall be made in writing to the address specified by the Agency in writing at the time of issue of this licence, or as subsequently specified by written notification to the Licence Holder;
