This CAR Form confirms receipt of the 2016 Annual Review of Environmental Monitoring for South Side Queensway Waste Management Site (Permit number EPR/HP3899FC).

The following comments have been made:

The risk of dust on aquatic life during dry conditions at Lagoons 12 and 25 is mitigated against through the restoration plan and regular maintenance. NRW have received no complaints or concerns regarding dust from the site or for any other issues at the site. The new monitoring schedule has been implemented as of 2016.

The report proposed actions that are reflected in this CAR Form:

- The integrity of the site boundary should be checked to ensure members of the public cannot gain access.
- Vegetation in the vicinity of several sampling points requires routine clearance to enable continual safe access.
- The AMP suggested leachate breakout monitoring should compromise six monthly site walkovers, particularly around the embankments of Lagoons 12 and 25. This needs to be implemented.
- There should be an annual walk-over each springtime to look for evidence of shallow translational slips along the embankment of Lagoon 12.
