3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

A1 Specified by Permit

Through correspondence with the operator NRW understands that the bio-filter and abatement system are not operational due to a lack of 3-phase supply. Without an operational bio-filter and abatement system bio-aerosols made build up within the building.

This is a **Category 3 permit breach** with respect to **Permit condition 2.1. schedule 1, table S1.1.**

C1 Staff Competency and Training.

Evidence has not been submitted to NRW regarding the enrolment of Mr Roberts onto a suitable WAMITAB course. Furthermore, no details have been provided to show that a Technically Competent Manager has been appointed to oversee the activities on the permit whilst Mr Roberts completes the course.

This is a **Category 3 permit breach** with respect to **Permit condition 1.1.1b “The operator shall manage and operate the activities using sufficient competent persons and resources”.**

G4 Reporting and Notification

Waste returns

Section 4.2.2 of the permit requires that waste returns are submitted to NRW within one month of the end of each quarter. Waste returns have not been submitted by the Operator since quarter 2 of 2018.

This is a permit breach with respect to **permit condition 4.2.2.**

Action: Submit all missing waste returns by 1st February 2021
