This was an arranged visit to carry out an audit on the site Fire Prevention and Mitigation Plan (FPMP), the most recent version (version 1.0) on file was submitted to NRW on 20/02/2018. The audit was carried out by Regulating Officer Steven White who met with Steve Rymill, Ken Hassel and H&S manager Bernie Carr.

Waste accepted onto site is treated via a picking-line in the main building and then stored on concrete flooring (which has been re-surfaced since this audit (05/07/18)) and separated by 'lego-block' bays. There are no sprinklers in the main building, 35 fire extinguishers situated around the site (Appendix C) and two water hydrants (Appendix D) situated in the main road for use by NWFRS.

At the time of the visit there was approx. 400T of pre-treated waste in the main building (see photo below) prior to it being put through the picking line



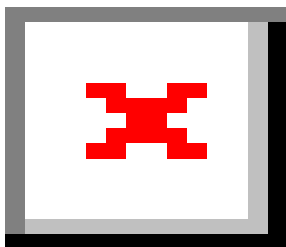

The main source of ignition in the main building would be overheating/malfunctioning equipment or from a rogue battery in one of the skips. There are 4 fire extinguishers in the picking line and, whilst operational, there are usually 7 staff in this area; any fires would quickly be seen and dealt with according to the flow diagram in section 3.2. There are 16 CCTV cameras stationed around the yard with viewing screens in the main office, there is also a notification system in place for some members of staff if any of the sensor on site are triggered out of hours.

Fines from the trommel are deposited in a pile to the north of the site(see photo below) prior to being put through the 'BlueMac' machine with other C&D waste

There is an interceptor on site situated to the south of the main sorting building which is inspected regularly and last emptied in February 2018; this flows to foul sewer as shown on drainage plan (Appendix D). There is not a penstock valve on site.

Site plans and training for the site were assessed, there are 16 staff on site with 2 fire marshals on the yard (with 2 more to be put through the training). Training and site fire extinguisher checks are carried out by Fire Line who are due another check in July 2018.

In addressing the points raised above it should not be relied upon to mean that the measures are considered to represent appropriate measures covering every eventuality through operation of the permit. Your FPMP should be kept under constant review to ensure measures remain effective. You must also ensure that the plan is fully implemented on site at all times. The plan should be revised where necessary in accordance with Section 24 - Reviewing and Monitoring your Fire Prevention & Mitigation Plan of the guidance.

In a future compliance assessment visit, we will undertake an assessment of your compliance with your FPMP.
