4. Details of our assessment

Compliance Assessment Report – Biffa Waste Services Ltd, Viking Place (EPR-SP3795FZ)

Officer David WARWICK-BROWN visited Biffa Waste Services Ltd's site at Viking Place at 10:30-10:55 on 01/12/2020, for a routine inspection and for Officer WARWICK-BROWN to be introduced as the new Regulatory Officer for this site. The Officer met with Transfer Station Manager and Technically Competent Manager (TCM) Owen Thirkettle at 10:30, and the weather was dry and sunny at the time of the inspection.

Site inspection

The Officer was led around the site and taken through the day-to-day operation of the Waste Transfer Station and the Mixed Recycling Facility (MRF). Following this inspection there are no major issues to be reported with this site, which was evidently well organised, clean and tidy. As a result, no breaches to the permit have been scored on this occasion.

There has been no significant impact to the site as a result of COVID-19 and the business has been largely unaffected, which was pleasing to hear.

The sites impermeable surface and drainage system appeared to be intact, and waste material from run-off is managed with an interceptor and storage tank, which is emptied as and when required.

The TCM's most recent WAMITAB continuing competency certificate was in date and displayed within the site's office – NRW did not have a copy of this on file prior to the visit, so this was scanned and sent to the Regulatory Officer following the inspection.

The only minor issue identified during the inspection was that the height of one of the waste piles within the MRF seemed quite high; although difficult to judge the exact height, it appeared to be close to the 4m maximum storage height, as shown below.
