4. Details of our assessment

NRW received a response from Siemens Energy Ltd. on 9th November 2020 in respect of the Improvement Programme (detailed in Table S1.3 of the permit), items IC7 and IC11. NRW has reviewed the response and comments are provided below;

IC7 - Effluent from the condensate polishing plant

The proposed approach for dealing with ammonia contaminated effluent is accepted i.e. transfer to the Nash Treatment Works. This represents a good environmental outcome especially from the perspective of minimising transport requirements and also ensures effective treatment prior to final discharge. If at any stage it is proposed to change this disposal route then an updated impact assessment may be necessary.

The improvement condition is confirmed as **Complete**.

IC11 - Black Start Operation

NRW accepts that a full and detailed response to this item is not appropriate at the present time as the installation has ceased power generation and is being managed under a preservation plan. However, the requirement to complete the item remains and an appropriate completion date will need to be agreed between NRW and the Operator when it is confirmed that power generation is planned to recommence.

The improvement condition remains in place with a completion date to be agreed.
